**Synopsis title:** synopsis title in square Bold Title Case (Times New Roman - font 14) with the sub-theme, and nature of the paper (theory, practice, policy/ governance, education/research, legal, international issues) to which it relates, respectively indicated immediately after in a first, and second brackets in italics (Sentence case -font 12)

**Abstract:** not more than 250 words **Keywords:** not more than five (5). **Divisions/Headings and Sub-divisions/Sub-headings:** as appropriate and based on importance index, subject matter, paper objective(s), and numbered serially for reference purpose e.g. 1.1, 1.2, 1.2.1, 1.2.2, etc)

**Figures / Tables:** to be properly numbered, and identified and /referenced within the paper; table-titles-above and figure titles below the table / figures, respectively.

**Author(s) names / address(es) / emails:** in their full appellations, with corresponding author indicated by an asterisks\*. This should reach the Secretariat not later than 24th November, 2017, and full paper by 29th December, 2017. On submission, authors will be advised on the acceptance of synopsis, full paper, and date, and mode of paper presentation. All submissions (except for synopsis title) must be made in Times New Roman font 12. Authors are please to note that submissions may be rejected for non-adherence to the above specification.
